FOUR BROOKS WMA GROUNDS RULES (EFFECTIVE 1-1-2025)

MONTHS OF USE: Exclusive Area: Ten (10) Months (January 1 thru October 31 annually).

Non-Exclusive Area: Varies - (January 1 thru the Friday nearest September 15 annually).

1. The consumption of alcohol is prohibited prior to or during any formal or informal grounds activities.
2. Everyone must wear at least one article of blaze orange (hat, shirt, vest or jacket), except in the parking area and during sanctioned events at which live ammunition is prohibited.
3. Camping is permitted only in designated areas.
4. Open fires are not permitted.
5. All trash, including spent shells and dead birds, must be removed from the grounds.
6. Dogs must be staked out, in kennels or on lead, in the parking area. Dog feces must be picked up and properly disposed of.
7. Unattended horses must be in trailers, corralled, staked or tied in designated areas. Horse manure must be removed from the parking area.
8. ATVs are permitted for use in 2 circumstances. 1. ATVs are permitted during sanctioned Federation events. A maximum of four (4), ATVs may be simultaneously operated on the premises. 2. Use of an ATV is also permitted by members who have a valid handicap permit and written permission from the MFFTC for the purpose of dog training. All ATVs must be properly licensed. ATVs may not be used when conditions would cause rutting or excessive soil disturbance.
9. Motorized vehicles must remain on designated roads. At no time are vehicles permitted in the field areas, except ATVs as per number 8 above.
10. Pigeons, chukars, bobwhite quail, mallard ducks and ring-necked pheasants may be released and shot for the purpose of dog training, trialing or testing. Ducks and pheasants must have, at least, an eight inch long, blaze orange streamer, attached to one leg prior to being released. The shooting of birds, after the day of release, is prohibited. Scratch hunting is illegal.
11. At the conclusion of any event, all signs and course flagging must be removed.
12. Training permit ID passes must be completely filled out, signed and prominently displayed on vehicle dash area when training on the premise.
13. Before entering and leaving the site, check clothing, gear, vehicle and equipment and remove caked mud, dirt clods and reproductive plant parts (seeds, berries, fruit, cones, flowers or seed stalks, and roots).

Annual training pass.....	\$50.00
Grounds fees (Reserved by member clubs).....	\$100.00 per day
Dog tax (levied when grounds are reserved for trial or test)	\$2.50 per entry
Dog tax (levied when grounds are reserved by member club for training)...	\$2.50 per dog on grounds
